Screen Warranty
20 YEAR LIMITED WARRANTY



This warranty card covers Speed Screen®, Speed Screen® Elite, Small Hole Speed Screen®, Small Hole Speed Screen® Elite, Drop-in Screen, Small Hole Drop-in Screen, Small Hole Elite Drop-in Screen, and Extreme Screen which will all be referred to as the “Product” for the rest of this document.

Lynch Aluminum warrants to you, the owner of the property at the time the Product was installed, that the Product is free from defects in material and workmanship in the course of manufacture, and that the finish on the powder coated screens will not blister or chip under conditions of ordinary wear.

This warranty does not cover damage of any kind resulting from improper use, improper installation, fire, flood, ice, hail, storm, windborne objects, tornado, earthquake, or other acts of God, use of incompatible accessories, exposure to harmful materials or chemicals directly applied or in the atmosphere, falling objects, settlement of the building, failure of the structure, external forces, mildew accumulation, surface oxidation, normal weathering, failure of owner to provide reasonable and necessary maintenance, or any other similar or dissimilar occurrences beyond the control of the manufacturer. This warranty shall remain in force for twenty (20) years as long as the owner(s) named in this certificate own an interest in the property as identified herein. Warranty coverage is subject to the conditions, remedies, limitations, and legal rights set forth herein and is non-transferable or otherwise assignable..

Claims under this warranty must be made in writing to Lynch Aluminum Mfg. Co. within thirty (30) days of the date the defect is first discovered or reasonably could have been discovered. Lynch Aluminum Mfg. Co. shall have a reasonable opportunity to inspect the product involved for defects and may request additional information or evidence concerning your claim which may include the submitting of pictures or other documentation of claim. If the product contains a defect covered by this warranty, Lynch Aluminum Mfg. Co. at its sole discretion, will either;

- a) pay for the cost of materials to repair or replace the product
- b) provide a replacement product of equal quality or value as a substitute
- c) refund the purchase price of the product.

In no event shall Lynch Aluminum be obligated to pay for the cost of labor for such repair or maintenance. Except as set forth herein, Lynch Aluminum Mfg. Co. makes no other warranties with respect to the product, expressed or implied, and shall not be liable for any incidental, indirect, consequential, or special damages with respect to the products covered by this warranty. Lynch Aluminum Mfg. Co.’s complete liability and the owners exclusive remedies are limited to repair, replacement, or refund on the basis stated herein. This warranty shall apply only to the product shipped to and used within the Continental United States. All the foregoing conditions constitute material terms of this warranty and violation by the owner or its agents or representatives of any one or more conditions shall release Lynch Aluminum Mfg. Co. of its obligations hereunder.
